## CALL TO ORDER

Tammy Nuccio (53<sup>rd</sup> Dist.), 1<sup>st</sup> Selectman Kevin Cunningham (*Plainfield*), and Dr. Carol Williams (*Ossen Foundation*) for attending this morning's meeting.

# ACCEPTANCE OF PREVIOUS MINUTES

A **MOTION** was made to accept the minutes from the May 24, 2022 EWIB Board of Directors meeting, as presented (**BUTLER/MONAHAN**). **ACTION**: Unanimously approved.

#### CORRESPONDENCE

- <u>CT Mirror Article</u> Chairman Jewell reported that he and staff participated in an interview with the publication over the summer as part of a project that is taking ". . . a closer look at workforce development programs support[ing] Electric Boat." The article is expected to be published this fall.
- <u>CareerConneCT Award</u> EWIB received a "Notice of Intent to Award" in the amount of \$1,782,691 from the CT Office of Workforce Solutions (OWS) as the "sole source" to provide technical infrastructure projects for the CareerConneCT grant.
- Jeffrey P. Ossen Family Foundation Guy Saporito, EWIB Chief Financial & Administrative Officer, reported that in July, EWIB received the second-year award from the Foundation for YMPI. In June, an orientation meeting was held with the Foundation's new leadership and Board members.

## CHAIRMAN/MANAGEMENT REPORT

- <u>Visit from Dignitaries</u> U.S. Rep. Joe Courtney (CT2) hosted U.S. Secretary of Labor Marty Walsh on August 16<sup>th</sup> where they were joined by CT Gov. Ned Lamont, U.S. Sen. Richard Blumenthal, and other state and local stakeholders to tour the Three Rivers Community College Manufacturing Apprenticeship Center (MAC) at Grasso Tech and announce EWIB's receipt of a \$7.85M grant (the largest in the nation) from USDOL for CareerConneCT the statewide expansion of EWIB's Manufacturing Pipeline Initiative (MPI). A brief video on the MPI program was played. Media coverage was strong ℰ across multiple platforms.
- <u>New Initiatives</u> Chairman Jewell reported on several key components of the CareerConneCT grant for the region included 1) Sustaining the efforts of the EAMA Regional Sector Partnership (EAMA RSP),
  2) Expanding & enhancing the YMPI to add additional schools & reach down into the middle & elementary schools, 3) Creation of a Healthcare RSP, and 4) creation of a Healthcare Youth pipeline.
- <u>2022 Summer Youth Employment Program (SYEP)</u> Ms. LaBelle, EWIB Sr. Dir. of Programs & Special Projects, reported on this year's program noting that there were ~1,500 applicants, with ~440 youth enrolled, working at ~130 worksites, and noted that 94% of participants completed the program. She noted that some youth will remain in their positions year-round. Worksites included information technology, healthcare, maintenance, office/clerical, finance, and more. Funding for this year's program (~\$1.2M) was received from:

- <u>Financial & Administrative Update</u> Mr. Saporito provided a status report on the following: Hybrid meeting capabilities and timeline, banking disbursement system changes, and the financial restitution on check fraud that occurred last spring. He updated the group on EWIB's FY22 operating budget noting that the final expenditures came in at 4.3% under budget, which was better than what was forecasted in May. He also provided an update to EWIB's FY23 revenue availability, which more than doubled in May's conservative forecast. An additional \$15.51M has been secured, primarily frp, mew grant and contract acquisitions, bringing the revised total to \$30.94M.

## COMMITTEE REPORT

<u>Executive Committee Report</u> – Chairman Jewell informed the Board that the Executive Committee meet with EWIB President/CEO Mark Hill earlier this month where they accepted his resignation due to ongoing health issues. The Committee has engaged the services of HR consulting firm, Foster Associates, to assist with the search and selection process for a replacement. In the interim, senior management will continue to jointly handle the leadership needs of the organization.
